MEDICARE AND PODIATRISTS

Current Status

The Medicare Act is the only nation-wide health insurance plan for people over 65 which does not specifically provide the services of podiatrists for covered benefits.

President Johnson considers the exclusion of podiatrists a defect in the program. The prepared remarks issued by the President when the Bill was signed in Independence, Missouri, on July 30 included the following: "...the benefits under the law are as varied and broad as modern medicine itself...and if it has a few defects--such as the method of payment of certain specialists, or the exclusion of podiatrists--those, I am confident, can be quickly remedied..."

The Recommendation

Amend Public Law 89-97 to assure older people that the needed services of podiatrists will be available when the program becomes effective July 1, 1966.

What Would This Change Cost?

There will be <u>no increased cost</u> because the schedule of services available will not be changed. Claims for services of podiatrists, as with other health benefits plans, would only be submitted for those services covered by the contracts. Patients should not be penalized for selecting a podiatrist to provide a covered service.

Is the Care of the Foot Included?

Yes. The treatment of injuries, deformities and some other conditions of the foot are covered services. In other words, the plan includes some services normally provided by the podiatrist but excludes the use of the podiatrist for these covered services. What is One of the Problems Older Persons Will Encounter When They Become Eligible for Medicare Benefits?

Health insurance carriers have stated that people who have subscribed to health benefits plans before they become 65 will find that the services of podiatrists for covered benefits will no longer be available when they become enrolled in the supplemental health benefits plan for Medicare beneficiaries.

What is the Incidence of Foot Problems of Those Over 65?

-

Older people have three times the incidence of foot problems as the general population. Forty percent of the patients treated by podiatrists are over 65.

What are Podiatrists Doing to Decrease the Cost of the Medicare Program?

Keeping the older person <u>ambulatory</u> is not only beneficial both physically and mentally, but has definite economic advantages. Foot disability contributes to accidents and encourages inactivity. The cost of caring for ambulatory patients is one-third that of bedridden patients. Seventy-three percent of all podiatrists have instititional affiliations such as hospitals, clinics, nursing homes and homes for the aged.

In Philadelphia, a three-year Public Health Service-supported podiatric health educational, screening and treatment program called "Keep Them Walking" attracted over 1500 older persons. Foot conditions averaged 7.8 per patient. <u>None</u> of those under treatment <u>required hospital or bed confinement</u> for a foot infection; no patient lost a foot, limb or part of a foot due to amputation. Also, no patient had an accident while attending the podiatry clinic sessions or limited his activities due to a painful foot.

What Training Does the Podiatrist Receive and Where is He Licensed?

The training program is six years--with two years of pre-podiatry courses followed by a four-year degree conferring course. Podiatry colleges are accredited by the Council on Education of the American Podiatry Association. The Office of Education recognizes the Council on Education as the official accrediting agency for podiatry colleges.

Podiatrists are licensed in every state and the District of Columbia by state examining boards. Laws in each state provide for the medical and surgical care of the foot by doctors of podiatry.

Are the Services of Podiatrists Recognized for the Federal Employee Plans?

Yes. Podiatrists are defined as a "physician" and "doctor" by the Government-Wide (Blue Shield and Aetna) health benefits plans for active and retired federal employees.

Also, all the federal employee organization plans recognize the services of podiatrists for covered benefits which their various plans provide.

Dear Mr. Dole:

Thank you for writing in regard to covering podiatrists under the medicare program.

The Republican alternative to the medicare plan would have defined podiatrists as a doctor. To the extent foot treatments normally provided by podiatrists were covered, a podiatrists' services would have been treated on the same basis as other doctors. However, in accordance with the prevailing practice in the insurance industry, my bill would have excluded payment for routine care of the feet.

The Administration's plan did not cover podiatrists, and they did not see fit to amend the bill to include them. Although I see no objection to an amendment that would cover treatments by podiatrists when they involve covered services, it is doubtful that the Committee will consider amendments to the program until we have had more experience with its operation.
