Re: Social Security Bill - 11865


While I am sure that you are aware of all of the sound reasons why this socialistic legislation is completely undesirable, let me remind you that:

2. Voluntary health insurance is doing the job.
3. Medicare benefits under social security would be fantastically expensive.
4. By adding medicare to the social security system, the already enacted benefits would be jeopardised.
5. Medicare would inevitably lead to the socialization of the practice of medicine.
